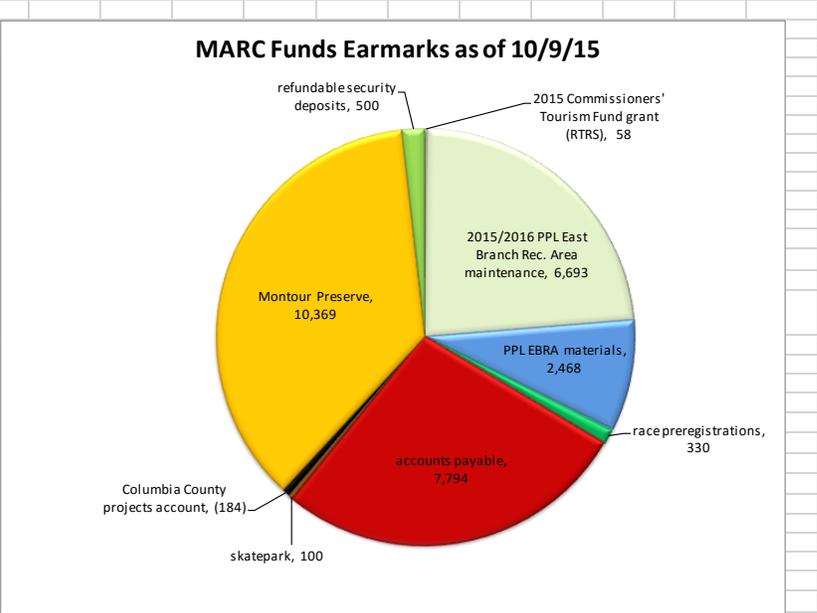

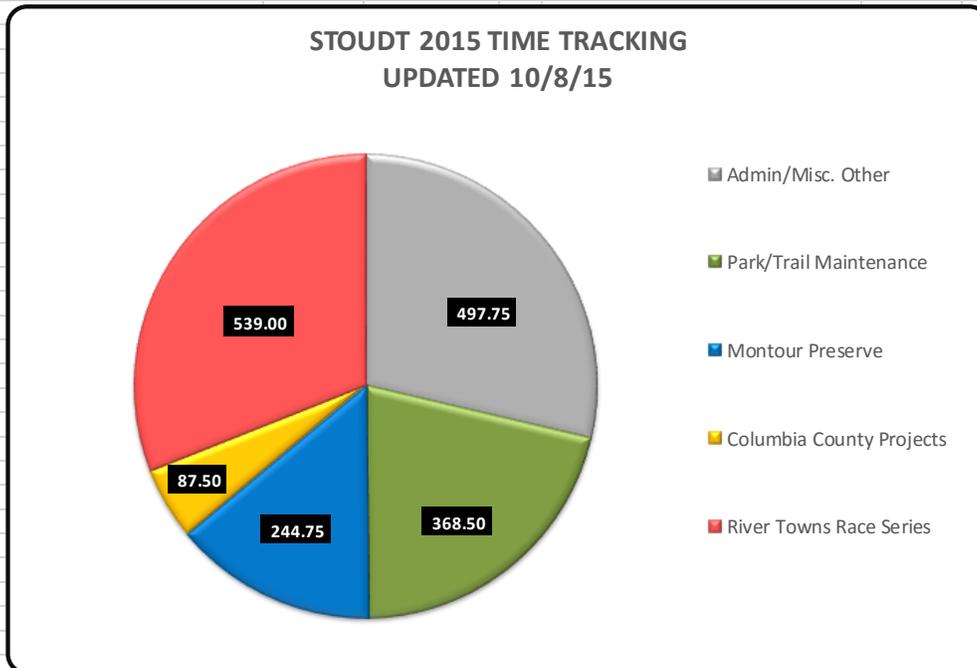

GRANTS

- Montour County Commissioners' 2015 Tourism Fund grant
 - \$15,000 received on 1/5/15 for 2015 River Towns Race Series advertising and promotion
 - \$58.37 remains earmarked for Nov. – Dec. advertising
 - Close-out report will be submitted to CMVB before year-end

- Merck Cherokee donation
 - MARC received \$2,500 on 11/17/14 to be used solely for North Branch Canal Trail expenses
 - Funds applied to Greenway Sign Grant (North Branch Canal Trail signage) expenses
 - Close-out letter will be submitted this month

- Susquehanna Greenway 2014 Mini-Grant Program
 - Trail mileage, caution and misc. signage installation is in progress along sections of completed trail
 - Mahoning Township trailhead kiosk installed before 10/1 trail opening; Catawissa (Montour Twp.) kiosk expected to be installed spring 2016 (subject to Susquehanna Greenway approval)
 - Expense reimbursement request will be submitted this month

- Williams Transco Pipeline Atlantic Sunrise Project / The Conservation Fund Environmental Stewardship Program
 - funds (\$146,000) have been received by the Susquehanna Greenway Partnership
 - MARC may submit invoices for reimbursement

PROJECTS/MANAGED SITES

- PPL East Branch Recreation Area
 - No progress on State Police vandalism investigation
 - \$6,693.28 remains earmarked in our account for site maintenance through April 30, 2016
 - \$2,467.78 remains earmarked in our account for supplies

- River Road parcel (North Branch Canal Trail trailhead and river access)
 - Major site improvements (brush/tree clearing, parking space construction, sign/garden installation) completed in September; sign/garden installation and most tree/brush clearing completed by Eagle Scout candidate
 - Property continues to be managed as part of MARC's mowing contract
 - Additional site enhancements will be done in coming months as schedule permits

PROJECTS/MANAGED SITES (continued)

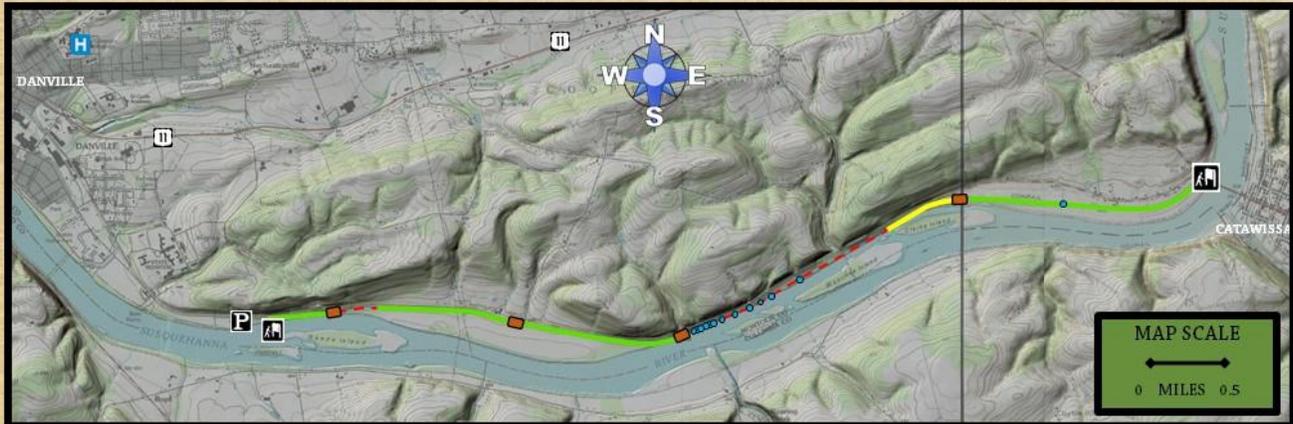
- Hess Recreation Area
 - Skatepark (no change since last meeting)
 - \$100 remains earmarked in our account for the project, specifically earmarked for reconstruction of the central pyramidal feature
 - Concrete cracks need to be sealed before they become worse
 - Ballfields (no change since last meeting)
 - Softball field needs two loads of infield mix (estimated cost \$1,000); Stoudt expects to order in spring 2016, funding permitting
 - Portions of the field turf will be seeded when weather conditions permit
 - Road (no change since last meeting)
 - MARC should consider a chip & tar coating of the road to extend its expected useful life; cost estimates will have to be sought when funding allows
 - Other
 - Construction of the Valley Township sewer line connector to the Danville sewage treatment plant is complete
 - the newly reconstructed Old Reading Line Trail is a uniform 8ft wide gravel surface, significantly better than the former condition
 - All repairs to the wetland blind entrance are complete
 - Additional petty vandalism continues to occur, including the breaking of trailhead kiosk Plexiglas panels and frequent littering around the skatepark and pavilion
- Hopewell Park / Danville Borough Farm
 - Dave Decoteau and trail volunteers have worked in recent weeks to improve existing trails and finish planned connections; work is now complete for 2015, though fixes may be required by Danville Borough or Montour County Conservation District after inspections
 - Trailhead signage has been placed regarding Saturday trail closures during the October – December hunting seasons
 - Planning for trail directional signage is under consideration
 - Stoudt/Beam will do additional park/trail maintenance in coming weeks, including replacement of the tire culvert with a wooden bridge
- Montour Preserve
 - \$118,064.55 raised to date from 197 donors (includes anticipated \$10,000 from Montour County Tourism Fund and Act 13 funds)
 - Lease agreements signed on October 1; MARC assumed control of portions of the Preserve that same day, including publishing the www.MontourPreserve.org website
 - Stoudt and Beam working with Talen Energy staff to move materials between buildings and get facilities ready for MARC use
 - Site signage has been updated with MARC logos and contact information; additional signage upgrades will be ongoing
 - Trail and garden work days are being scheduled
 - Public presentation scheduled for Tuesday, 10/13

PROJECTS/MANAGED SITES (continued)

- North Branch Canal Trail
 - 0.4 mile-long section of trail in Mahoning Township, Montour County opened on October 1; 50+ in attendance; food donated by Pine Barn Inn; beverages donated by Bason Coffee Roasting
 - 841 volunteer hours donated to the project since December 2013
 - Trail construction is finished for the 2015 season, except that Stoudt will finish additional sign post installation along completed portions of trail
 - Stoudt will work with Brinkash & Associates to put together bid documentation for culvert installation and trail grading work in spring 2016
 - Stoudt continues to work with Brinkash and Associates to finalize trail bridge engineering and permitting with a goal of project bidding and construction in spring 2016
 - Grant funding has been received by Susquehanna Greenway Partnership; MARC may submit invoices for reimbursement as needed
