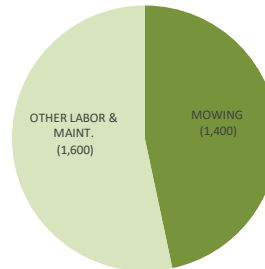

2019 HOPEWELL PARK BUDGETED EXPENSES



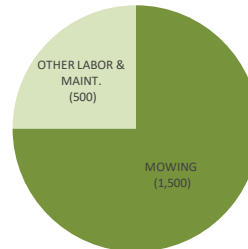

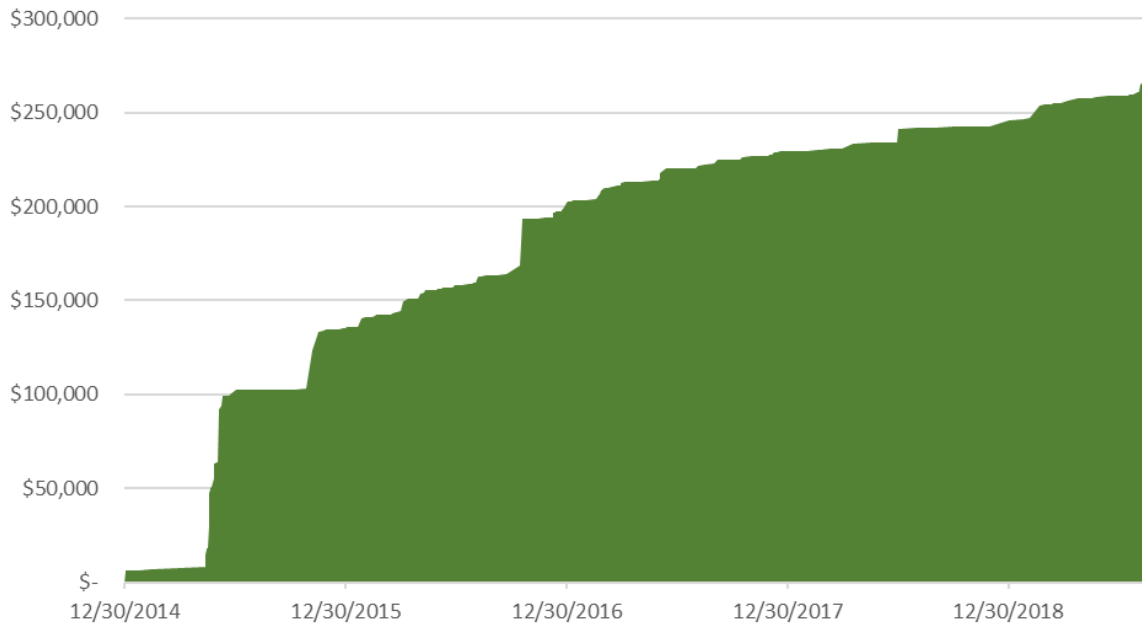

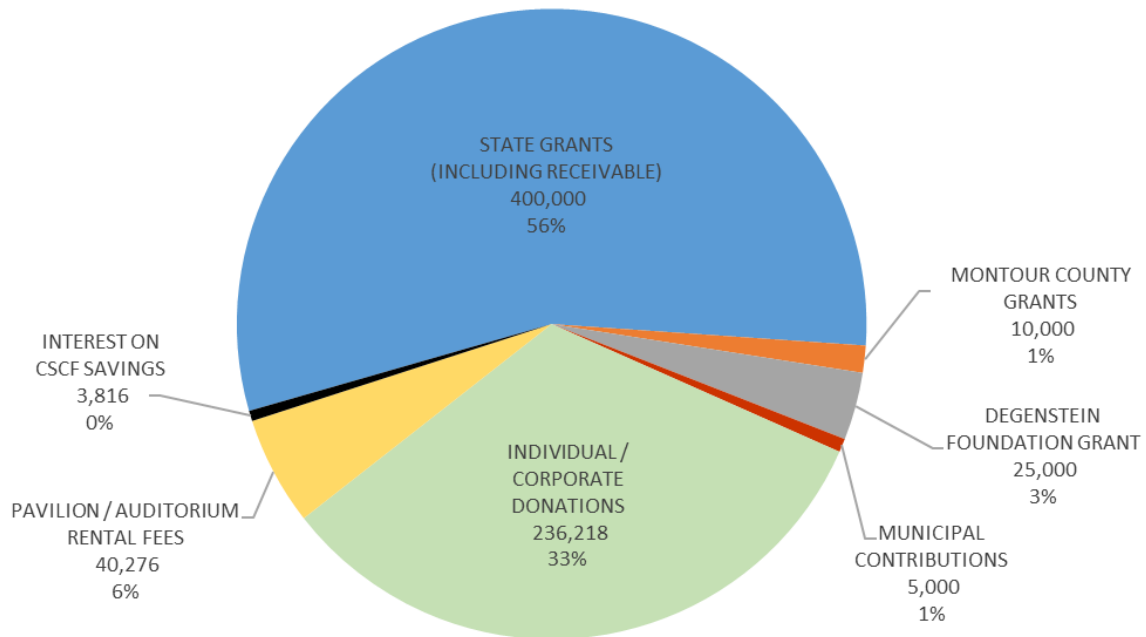

GRANTS

- **DCNR 'Heritage and Other Parks' Grant (Montour Preserve)**
 - Initial \$100,000 grant was twice amended to a total of \$300,000 and extended through 6/30/2019
 - MARC's request for an extension of the grant term from 6/30/19 until 6/30/20 has been approved to allow for the successful completion of all end-of-grant administration and auditing
 - As of 8/22, all funds have been expended (except that \$30,000 (10% of total grant amount) will remain held by DCNR until the successful completion of the performance audit at the end of the grant term)
 - Stoudt will submit grant materials and accounting records to Brewer and Associates for the required end-of-grant performance audit as soon as MARC's Employee Theft insurance policy is in place and all other mandated items are verified as complete (anticipated by mid-September)
- **DCED Marketing to Attract Tourists Grant (Montour Preserve)**
 - MARC on 4/15 received and deposited to a dedicated checking account the \$100,000 grant disbursement
 - to date, MARC has earned \$506.93 in interest on the grant funds
 - MARC must not spend interest earned on this grant; interest earned will have to be returned to DCED at the end of the grant
 - to date, MARC has spent:
 - \$30,000 on 5/8 for tractor purchase
 - \$4,500 on 6/26 for the first payment for the HVAC systems replacement
 - \$19,000 on 7/23 for the second payment for the HVAC systems replacement
 - \$46,500 remains earmarked in MARC's account for the remaining balance on the HVAC systems replacement (an invoice for \$9,000 has been received and is being processed for payment) and for the anticipated visitors' center roof repair
 - A problem has been discovered with the electrical specifications of the HVAC components which were contracted and ordered versus what is actually wired in the buildings
 - MARC leadership is working with the contractor to identify the most cost-effective and viable fix for the problem
 - Stoudt anticipates requesting Board approval for a contract change order during this meeting to allow the project to be successfully completed
- **Montour County 2019 Act 13 (Marcellus Legacy Fund) Grant**
 - Stoudt on 2/6/19 submitted a request for \$25,000 in grant funding from Montour County's Act 13 (Marcellus Legacy Fund) for MARC's 2019 general operations
 - \$5,000 received and deposited by MARC on 3/12
 - \$20,000 received and deposited by MARC on 7/5

MANAGED SITES

- **River Drive parcel (North Branch Canal Trail trailhead and river access)**
 - No change since last meeting
- **Montour Township (Columbia County) Legion Road parcel**
 - No change since last meeting
- **Riverside Borough river access**
 - No change since last meeting
- **Hopewell Park / Danville Borough Farm**
 - MARC has to date received \$67.50 in criminal restitution for damages caused during the 3/23 break-in and vandalism incident at the pig barn
 - Stoudt anticipates eventually receiving an additional \$82.50 in restitution to fully reimburse MARC's \$150 cost to repair the incident damages
 - No new break-in attempts at the pig barn have been recorded since MARC's last meeting
- **North Branch Canal Trail**
 - Trail conditions remain wet, limiting mowing and other maintenance activities
 - Trail Steward Wayne Kashner has removed numerous fallen trees and repaired many sections of trail since MARC's last meeting
- **Hess Recreation Area**
 - MARC staff and volunteers have this summer cleared numerous storm-caused fallen trees
 - MARC staff continue to monitor the slumping section of the Robbins Trail, but no significant changes have been observed since MARC's last meeting
- **Montour Preserve**
 - Site conditions remain wet in many places, hindering mowing, trail maintenance and other activities, but progress has been made in recent weeks to catch up with work that was delayed earlier in the year
 - MARC has rented a mower deck which can be mounted to the front of MARC's new tractor, allowing for much more efficient trail mowing and vegetation trimming
 - Stoudt and Piatt believe the mower deck would be a wise purchase for MARC; Stoudt will request Board authorization for such a purchase during this meeting
 - Girl Scout Troop 60089 from Danville has been repainting the picnic tables in the Heron Cove Picnic Area and is preparing in coming weeks to construct turtle basking platforms and new trail benches
 - Work is well underway on the replacement of the HVAC systems in the visitors' center and environmental education center, but contractors have discovered a problem with the electrical specifications of the HVAC components which were contracted and ordered versus what is actually wired in the buildings
 - MARC leadership is working with the contractor to identify the most cost-effective and viable fix for the problem

DIRECTOR'S REPORT (continued)

OTHER UPDATES

- Stoudt on 7/22 met with a Loss Control Manager from PIRMA to review MARC's liability and property loss control procedures
 - no new recommendations were made; it was determined that prior recommendations have been completed
- Stoudt has remained in contact with the new owners of the recently sold parcel of land adjacent to the Geisinger Stewardship Forest and has developed a good working relationship
 - The new owners have expressed a willingness to work with MARC to possibly allow limited public access to the site
 - In cooperation with local mountain biking enthusiasts and trail volunteers, Stoudt will work with the new owners to draft a trail construction, usage and maintenance agreement for consideration by MARC's Board
- Stoudt has assisted with the logistics for several special events since MARC's last meeting, including the Danville Heritage Festival, Danville Health Fair, Numu Haakhana Pow Wow and several other smaller events
